BLACK traffic Light - not recommended for prescribing in primary or secondary care.

- **Daratumumab with lenalidomide and dexamethasone** – untreated multiple myeloma [terminated appraisal] [NICE TA634](#)
- **Ramucirumab with erlotinib** – untreated EGFR-positive metastatic non-small-cell lung cancer [terminated appraisal] [NICE TA635](#)
- **Eculizumab** – refractory myasthenia gravis [terminated appraisal] [NICE TA636](#)
- **Ranibizumab** – diabetic retinopathy [terminated appraisal] [NICE TA637](#)

RED traffic light - Primary care prescribers should not be asked to prescribe
(* denotes NHS England Commissioned, ** denotes Cancer Drugs Fund)

- **Gepan® bladder installation** – specialist urology use for interstitial cystitis & other bladder conditions
- **Lorlatinib*** – previously treated ALK-positive advanced non-small-cell lung cancer – in line with [NICE TA628](#)
- **Avatrombopag** – thrombocytopenia in people with chronic liver disease needing a planned invasive procedure – in line with [NICE TA626](#)
- **Maintelyte® Solution for infusion** – fluid replacement infusion
- **Obinutuzumab** with bendamustine** – follicular lymphoma after rituximab – in line with [NICE TA629](#)
- **Ustekinumab** – moderately to severely active ulcerative colitis – in line with [NICE TA633](#) [BlueTeq form required]
- **Camouflage Creams** – when recommended by specialist nurse led service.
- **Latotrectinib**** - NTRK fusion-positive solid tumours in line with [NICE TA630](#)
- **Trastuzumab emtansine*** – adjuvant treatment of HER2-positive early breast cancer – in line with [NICE TA632](#)
- **Fremanezumab** – preventing migraine – in line with [NICE TA631](#) [BlueTeq form required]

AMBER Traffic Light - initiated by specialists but may then be passed to primary care for prescribing

- **Famotidine** - option when omeprazole or lansoprazole are not appropriate as substitute for ranitidine, which has current supply issues.
- **Relvar Ellipta®** - alternative DPI for asthma – initiation secondary care.
- **Lamotrigine** – mood stabiliser in bipolar disease.
- **WaveSense JAZZ Blood Glucose Testing Strips** – only for use in gestational diabetes
- **Cavilon® Advanced Skin Protectant** – severe skin damage, including painful skin stripping. Restrictions apply for use – on approval of Tissue Viability.(ELHE).
- **Anoro Ellipta®** - for COPD, to provide consistency of device, when stepping up/down to/from Trelegy Ellipta®
- **Lamotrigine** – licensed use as a mood stabiliser in bipolar disease.

GREEN Traffic Light - may be prescribed by all prescribers within local or national recommendations

- **ExoCream®** – cost effective equivalent to E45® cream
- **VitA-POS® eye ointment** – name changed to Hylo Night ointment
- **ExCetera® cream** – name changed to Epimax® ExCetera cream
- **Medi Derma Pro Cleanser and ointment** – replaces ProShield spray cleanser & skin protectant. (ELHE)
- **Medi Derma-S** – mild to moderate skin damage(first line)(ELHE)
- **Medi Derma-Pro** – moderate & severe skin damage (second line)(ELHE)
